The incentive cannot be used as the State share in project in the AMRUT, but iii. can be used by the ULBs for their project funding.

- Unutilized funds for Reform incentive will be transferred to Project Fund every iv. year.
- This release will be governed in terms of provisions of GFR 2017. ٧.
- No Utilization Certificate is pending in respect of Reform incentive. 3.
- The expenditure involved is debitable to the Major Head-3601-Grants-in-aid to 4. State Govts., 06-Centrally Sponsored Schemes, 06.101-Central Assistance /Share, 24-Urban Rejuvenation Mission-500 Habitations (AMRUT) 24.01- Urban Rejuvenation Mission-500 Habitations (AMRUT), 24.01.31-Grants-in-aid-General under Grant no. 56 (Plan)-Ministry of Housing & Urban Affairs for the financial year 2018-19 (Plan).
