**Subject: Release of balance amount of 1<sup>st</sup> installment of Central Assistance (CA) amounting of Rs. 3,34,00,000/- (Rupees Three Crore Thirty Four Lakhs only) (the approved CA towards Administrative & Other Expenses component of Rs. 13.36 Crore) to Govt. of Punjab under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) for year 2017-18.**

Sir,

In continuation of sanction letter of even number dated 28.02.2018 (copy enclosed), vide which an amount of Rs. 3.34 Crore was released to the State as 1<sup>st</sup> installment towards A&OE fund @ 2% of annual allocation under AMRUT, I am directed to convey the sanction of the Competent Authority for the release of balance amount of 1<sup>st</sup> installment of Central Assistance (CA) @ 2% of annual allocation under AMRUT, amounting to Rs. 3,34,00,000/- (Rupees Three Crore Thirty Four Lakhs only) to the Government of Punjab.

2. The additional Central Assistance for A&OE under AMRUT has been considered as per the Mission Guidelines.
3. The other terms & condition will remain same as per earlier letter dated 28.02.2018.
4. The expenditure involved is debit to Major Head 3601 – Grant in Aid to State Govts, 06 - Centrally Sponsored Plan Scheme, 101- Central Assistance/Share, 24-Urban Rejuvenation Mission- 500 Habitations (AMRUT), 24.01.31-Grants-in-aid General under Grant No. 97 -Ministry of Housing & Urban Affairs for the year 2017-18 (Plan).
5. The amount of Rs. 3,34,00,000/- will be credited to the State Government's account to RBI as per procedure laid down by Ministry of Finance, Department Expenditure vide OM No. F-II (45/76/SC) dated 22.02.1977.
6. The sanction has been entered at Sl. No. 51 of the sanction register.
